2. The quotation should be submitted **strictly in the enclosed format**, duly filled in and **signed on all pages**.
3. The envelope containing the quotation should be **super-scribed** as: "**Quotation for Supply of Korai Mats for Kalakshetra Foundation, Chennai – Due on 30.01.2026 before 1.00 PM.**"
4. The quotation should be addressed to **The Director, Kalakshetra Foundation, Thiruvanmiyur, Chennai – 600041**. Quotations submitted in any other format will be **summarily rejected**.
5. Submission of quotations through **e-mail or any electronic mode** will not be considered and shall be rejected without assigning any reason.
6. Rates should be quoted **inclusive of all taxes, duties, and delivery charges** up to the site. The quotation should reach this office **on or before 30.01.2026 at 1.00 PM**. The quoted rates shall remain **valid for a period of two months**, i.e., up to **30.03.2026**.
7. The decision of the **Director, Kalakshetra Foundation**, regarding acceptance or rejection of quotations and award of work shall be **final and binding**.
8. The supply of items shall be completed and delivered in **full quantity within 30 days** from the date of issue of the Supply Order / Work Order.
9. All correspondence relating to this quotation should be addressed to **The Director, Kalakshetra Foundation, Thiruvanmiyur, Chennai – 600041**.
10. A **sample of the item / finished product (one piece)** should be submitted for approval **before issuance of the award letter**.
11. If the materials supplied are **not in conformity with the approved sample**, such materials will be **rejected and returned**, and **no payment shall be made** for the same.
12. **No advance payment** shall be made. Payment will be released **within five (5) days** after satisfactory completion of the supply and submission of invoice, **through ECS**.
